Del-Air Lodge Redevelopment

Avanti Time and Attendance Payroll System

The Time and Attendance project is gaining momentum, with most of the structure already in place as we enter the scenario testing phase. Simultaneously, we will conduct Time and Attendance training (train the trainer), allowing NPHF to collaborate with the Avanti team to address questions and provide clarification. This approach aims to equip us with the necessary knowledge and understanding of the system, reducing our need for future assistance.

The current schedule has us parallel testing in mid-July, training staff into the beginning of August and going live for the August 15 pay run. Project close out is scheduled for the end of August 2024.

Wi-Fi Availability

Mighty Peace Wireless will be on-site at Heritage Tower Lodge on Friday July 5, 2024, to determine the requirements of the Wi-Fi installation.

Harvest/Homesteader/Heritage Tower Lodge Nurse Call System Replacement

ASCCI North Inc. has completed the installation of the Nurse Call and telephone systems at the Harvest and Homesteader Lodge. The systems are fully operational.

The installation at Heritage Tower Lodge is scheduled for the month of August. Equipment is currently being ordered in preparation for the project.

Insight Facility Advisors Operational Review

Insight Facility Advisors completed their review of NPHF sites and had the opportunity to meet with Maintenance and Administrative teams to get a better understanding of the history of the buildings' mechanical elements, processes, and operator skill level.

Insight will return in July to provide a Site Report including site level ratings for equipment and operations, individual equipment analysis, site summaries, and capital replacement cost budgets; an Executive Report including operational recommendations and a summarized compilation of capital budget projections. Staff training and development, including tasking and field technical training, and Yardi (Property Management Software) Quality Assurance Quality Control implementation will take place at that time.
